

2019-20 access and participation plan monitoring Provider impact report

This impact report summarises the progress made by Farnborough College of Technology against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

Farnborough College of Technology's ambition and strategy as detailed in the 2019-20 access and participation plan:

Our strategy was to continue our commitment to ensure participation of under-represented groups. The key areas for development were:

- a) those without an immediate family experience of participation in HE
- b) those living in disadvantaged socio-economic localities
- c) those drawn from specific under-represented Black and Minority Ethnic (BAME) communities
- d) those with a specific Learning Difficulty or Disability (SLDD)

We aimed to target funds at initiatives to increase the numbers of students from low participation neighbourhoods or from the Nepali Community. We also aimed to develop initiatives to encourage those with disabilities or those with a learning difficulty as well as those progressing from Level 3 from our own community of FE students. We aimed to improve communication of our bursary offer.

We aimed to target success by developing progression initiatives focussed on further improving non continuation rates for full time HE Students. We aimed to track students who were displaying the warning signs of non-completion of poor attendance and poor attainment by offering such students 1:1 time with a progress coach.

Progression: We aimed to enhance our progression guidance for HE students ensuring that Information, Advice and Guidance for students completing their HE courses is carefully targeted at those who are unsure of their next steps.

T16a_01	We have appointed progress coaches and have been monitoring attendance and progress at Boards of Studies. We have also ensured that one of our ALS staff is focussed on HE. Our 20-25 APP is targeting this in an attempt to get down to 10%.
T16a_02	We have an APP Action plan which is having monthly progress reports that are reported to SMT and to the Governing Body. We have also appointed Progress Coaches and LLDD focussed ALS staff
T16a_05	We will continue to develop our offer with more Accelerated Degrees and Degrees that suit the local population especially mature students. We are ensuring that 3 Year Degrees are delivered on 2 days per week and are increasing the number of accelelerated degrees which can be completted in two years
T16b_01	We have been running workshops for our own P4 Q1 FE students to encourage them to stay in HE. We have run workshops on applying to University, Introduction to HE, UCAS and Finance, Personal statements, CVs and Interviews, HE Apprenticeships and Work Experience

Annex A: Commentary on progress against targets

Farnborough College of Technology's commentary where progress against targets was less than expected.

Target reference number: T16a 01

How have you met the commitments in your plan related to this target?

Our non completion rates have been stable around the 15% level, in 16/17 it went to 17% and in 18-19 down to 10%. In 19-20 it was 15%. There could have been some impact from the Covid19 pandemic

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We now have a Head of Higher Education at the college. This post is able to focus on HE and attempt to ensure quality is maintained working on closer monitoring of student progress with ealier inverventions.

How have you met the commitments in your plan related to this target?

This figure of 23% from PQ1 & 2 is up from just 14% in the previous year, this is a return to the sort of number we have been able to attract

We are working with HEON to target low particiaption neighbourhoods. We are also ensuring that our own FE Students who live in these neigbourhoods are aware of the bursaries available

How have you met the commitments in your plan related to this target?

In the Baseline year this was 61 but in that year we had a much bigger HE student body and so we are now looking at this figure as a % and it has jumped around 27% in 16-17, 22% in 17-18, 29% in 18-19 and 26% in 19-20

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We are keen to keep our FE Students but to some extent we are victims of our own success in getting students into first choice Universities due to excellent success rates

How have you met the commitments in your plan related to this target?

We had planned to have 95 but these targets were set in 2012 before student numbers dropped when big Universities had their numbers uncapped.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We had 153 New Starts of which 20 were P4 Q1 or 2. This represents 13%. Of the 20 9 were Q1, therefore 6%. We have made this one of our targets in the 20-24 plan which targets Access to go up from 11% to 16% over the period.
